1. Call to Order:

Chairman called the meeting to order at 8:05am.

3. Reading and Acceptance of Minutes:

Chairman Ursone asked if all commissioners have read the minutes from the Regular Meeting held on February 11, 2018. He then asked for a motion to accept these minutes. A motion by Commissioner Cuscuna and second by Commissioner Moran and motion was passed unanimously.

5. Committee Reports:

i. List Update

Chairman Ursone stated that the survey resulted in 7 new responses and that Commissioner Etter had wanted to have the commissioners' follow-up with phones calls for the non-responders.

6. Old Business:

a. Bloomberg Philanthropies Art Grant-Due March 26th

Chairman Ursone asked if all commissioners had an opportunity to review the two (2) applications. He then asked if any commissioners had a conflict of interest, that they recuse themselves from the discussion and vote. However, the other commissioners could ask questions of them. Commissioners Colatrella and Wattles recused themselves. b. ARTWALK Social Media Contest

Mr. Varamo discussed the opportunity to have social media contest where the public would take selfies with the public art during ARTWALK.

Other:

- Commissioner Colatrella shared details about Seward Johnson Public Art Exhibit to be June through September for DSSD's ARTWALK. They will be displaying 35 pieces, one of which is the Forever Marilyn, a 26ft tall statue of Marilyn Monroe.
- Mr. Madden mentioned "Iconic Stamford" an Instagram contest that the Stamford Partnership will be promoting.
- Mr. Varamo shared the current status of the city-owned James Daugherty mural "The World Outside." Once the restorer begins in early summer, the restoration will take 6-8 months to complete. Next step will be to put together a timeline for a Homecoming Ceremony.
- Commission Moran shared a discussion that he had with the Mayor's office about a potential mural on the bridge of St. John's Towers and the wall of the Rich Forum.
- Commissioner Colatrella shared details about 'Make Music Day' to be held on June 21. 'Make Music' is a free celebration of music around the world. Stamford is one of 10 cities in Connecticut hosting this event. To participate, go to www.makemusicday.org/stamford
