### 1. Call to Order

3. Reading and Acceptance of Minutes: From Regular Meeting held on September 10, 2020 Chairman Winkel asked for reading of the minutes from the Regular Meeting held on September 10, 2020. He then asked for a motion to accept these minutes. A motion was moved by Commissioner Diamond and second by Commissioner Huerta. Chairman Winkel conducted a roll call vote. ### 4. Chairperson Report

Mr. Madden provided an update on Phase 3 of Reopening Stamford and a first violation was issued to a restaurant for noncompliance. The Economic Development Department has been very active in recruitment. He stated two new companies were moving to Stamford, one of which is a Fortune 1000 company and the other a startup company opening office space. He also gave highlights on other business employment opportunities. Mr. Madden stated he attended a meeting for Work force Development, "Next Gen", which is part of the Governor's Taskforce and provided the Commissioners with meeting highlights. Lastly, he recognized John Varamo for the article in Stamford Magazine that featured the work that was done for cataloging the City's public art collection and posting on Choosestamford.com. Mr. Varamo gave a quick update on the Arts & Culture Commission business, such as building a strategic plan and the Stamford Arts & Culture grant process and application.
