The Regular Meeting of the City of Stamford Economic Development Commission (EDC) Office of Economic Development (OED) was held on Thursday, December 10, 2020 at 4:04pm via Zoom Meeting on the 9th floor in the Urban Redevelopment Commission Conference Room, Stamford Government Center, 888 Washington Boulevard, Stamford, Connecticut.

1. Call to Order

Chairman Winkel called the meeting to order at 4:04pm. He also introduced and welcomed Margaret Feeney, as a new member of the Commission.

2. Roll Call

3. Reading and Acceptance of Minutes: From Regular Meeting held on November 12, 2020 Chairman Winkel asked for reading of the minutes from the Regular Meeting held on November 12, 2020. He then asked for a motion to accept these minutes. A motion was moved by Commissioner Diamond and second by Commissioner Huerta. Chairman Winkel conducted a roll call vote. Motion was passed unanimously.

4. Chairperson Report

Chairman Winkel there have been no new requests or opinions received. However, the pending opinions will be covered under Old Business. He stated that communications have been sent out in the past, that this service of reviewing Economic Development opinions to other boards and organizations is available. Possible, next steps would be to invite other organizations to the monthly meetings. Mr. Madden suggested to start with the Stamford Partnership, Mill River

5. Director's Report

Mr. Madden provided highlights of the Q3 Report which should be posted shortly to the website. He reviewed corporate leases and apartment rental information. He updated the Commissioners on an intern project being done by Mr. John Hicks, on his cultivating a corporate leader list for potential leads. This will be used to send out the first round of cold call folders. He updated the Commissioners on the housing sales and the drop in unemployment. Mr. Madden stated a second Stamford sign similar to the one by UCONN Stamford will be placed at 677 Washington Blvd for visibility on entering and exiting the train station. Mr. Varamo provided an update on the status of the Arts & Culture Commission strategic plan and the Stamford Arts & Culture Grants application process. Lastly, Mr. Madden updated the Commissioners on state and federal government monies to assist small business.

- a. Discussion of Meeting Agenda Items Chairman Winkel stated this item has been discussed at the last two meetings and the prospect of adding new items to the agenda. Based on previous feedback Commissioner Huerta will submit a draft to the Commissioners to be discussed at the next meeting for final presentation.

Mr. Madden stated a preliminary draft was submitted by Dr. Jackson. He stated, it will require further review for feasibility and further discussion is needed with the Mayor. A draft will be submitted for next meeting.

a. Approval of 2021 EDC Meeting Calendar Chairman Winkel requested a motion to approve the 2021 Regular Meeting Calendar for the Economic Development Commission. A motion was made by Commissioner Diamond with second from Commissioner Huerta. Chairman Winkel conducted a roll call vote. Motion passed unanimously.
