The Lab Director is assisting with COVID-19 Vaccination activities.</li> <li>• Dr. Getreuer read the Bedbound COVID-19 Vaccinations are ongoing. Dr. Getreuer explained these are one-on-one visits from Nurses, or other vaccinators to vaccinate homebound (typically seniors, but not necessarily) individuals who cannot get to vaccination sites.</li> <li>• Ms. Parry said she was under the impression this was not for people who were just at home and can't get to vaccination sites but the individual had to be physically bedbound, hence the use of the word Bedbound.</li> <li>• Dr. Getreuer read, the Homeless Shelter Vaccination program started yesterday, April 7<sup>th</sup>. Dr. Getreuer stated the issue with the Homeless Shelters is that there population frequently changes, so going there throughout the course of different weeks can impact the number of people who get vaccinated. Dr. Getreuer said the City is trying to my regular visits to the Homeless Shelter to ensure that everyone who is in the Homeless Shelters are vaccinated.</li> <li>• Ms. Parry said she understands this was written by Dr. Calder but she believes it would be more appropriate to say it's continuing, or restarted April 7<sup>th</sup>. the program occurred beforehand and it's continuing.

- Dr. Getreuer said Dr. Calder has worked with the Director of Pacific House and he believes one of the other organizations, and they all agreed because of the transmutation of the population, the Homeless Shelters need to be hit regularly, until so better system comes along.
- Dr. Getreuer read Restaurant Personnel Vaccinations is a coordinated effort to bring just the Restaurant Workers into the City's Vaccination Site, so they feel less afraid of coming forward and more likely voluntarily go to get vaccinated. The report stated this will occur starting April 13<sup>th</sup>.
- Dr. Getreuer read Contact Tracing continues. He said this continues with a full complement of what he now believes is a total of seventeen (17) or eighteen (18) Contact Tracers. DR. Getreuer said most of them are working fulltime, seven (7) days a week, twelve (12) hours a day.
- Dr. Getreuer read COVID-19 education activities targeting communities of color has launched. Dr. Getreuer stated he doesn't know the specifics on this but he is aware that the Department of Health is working with the Churches and other specific groups to reach Communities of Color, the Immigrate Community, and Building One Community.

- Dr. Getreuer read CT Health Foundation grant extended with an additional award of \$100,000.00 to support Community Health Workers (CHWs).
- Dr. Getreuer read the Department is still working with major staffing shortages. Dr. Getreuer said he doesn't have the numbers on this but he believes the number is in the high-teens of those who need to be replaced.
- Ms. Parry asked can the Health Commission receive a more detailed report next month about the staffing shortage and what are the plans going forward.
- Mr. Jankowski said he would like to start his report by discussing the Health Department first. He said 'we' have been in this pandemic for a longtime and the City has been preparing for it since back in January of 2020. Mr. Jankowski said that The City has conducted internal meetings with Emergency Management. Mr. Jankowski also said the Mayor has been exceptional from the beginning, as he has supported the City, getting everyone to think critically and coming up with great ideas himself all the way through. Mr. Jankowski reported The Mayor, Dr. Calder and himself has put in a lot of hours and are committed to their positions. Mr. Jankowski said he believes the City has addressed everything they could address, as best as possible, and although they may have had to adapt, they have tried to be as proactive as possible.

- Mr. Jankowski said the Health Department has done an excellent job, as well as Public Safety, and Schools. Mr. Jankowski defined excellent has far as the efforts in reducing the risk of what the City strives to accomplish.
- Mr. Jankowski stated the City has partnered with the Nursing Homes and the Hospital to ensure they had the PPE (Personal Protection Equipment) needed, as well as to find out how they were doing, probably even before the State was thinking about doing that. Mr. Jankowski said there has been so many positive and proactive initiatives, as the City has always tried to be ahead of the games.
- Mr. Jankowski said the City has also partnered with Community Groups and NAACP to get the word out to the Community about wearing mask, and how important it is to be tested.
- Mr. Jankowski acknowledged Dr. Fortt, saying she has been involved almost all the way though. He said Dr. Fortt was there during Mask Giveaways, Testing Locations and even Vaccination Sites. Mr. Jankowski said he appreciates all the work Dr. Fortt has been involved in with the City, even her efforts to reach the hard to reach communities.
- Mr. Jankowski also acknowledged Ms. Early, saying she has come onboard right in the middle of the pandemic and she has done a good job in supporting Dr. Calder.

- Mr. Jankowski acknowledged Dr. Calder, saying she has been trying to think outside the box, and be proactive in everything the City is doing. Mr. Jankowski said the Health Department staff has been working exceptionally, achieving a lot of the goals the City has sought out to achieve, while being understaffed.
- Mr. Jankowski acknowledged CERT & MRC Volunteers, saying they have done an exceptional job. Mr. Jankowski said CERT & MRC have been present at everything the City has asked for, including Mask Giveaways, Testing and Vaccination Sites. Mr. Jankowski said Ceremonies are to come to recognize these individuals.
- Mr. Jankowski reported the Health Department has two key vacancies. He said the Director of Environmental Inspections position is vacant, however Gail McRae is acting in the position. Mr. Jankowski said the City was without a Director of Nursing for a long time and Deidre Anspach, who retired has come back and rose to the occasion.
- Mr. Jankowski said there has been a “battle field promotion” with a few of the Nurses. Mr. Jankowski reported Moira Bryson has done an excellent job dealing with everything, as far as Contact Tracing within the Schools to being involved with the Vaccination program.
- Mr. Jankowski reported Jim Federici, Director of Laboratory is the VAMS Coordinator. Mr. Jankowski said Jim Federici is coordinating with

Mr. Jankowski said Public Safety had a popup vaccination site over at Rippowam Park the other day. Mr. Jankowski said PD went door to door to let everyone know there was going to be a Vaccination Program yesterday. Mr. Jankowski reported the turnout was exceptional, saying it was so good that the City was shy of forty (40) vaccinations.</li> <li>• Mr. Jankowski said in regards to the Vaccination Program, the City has partnered with Stamford Health and he believes that to be going very well. Mr. Jankowski said anyone who has gone to get their vaccine there, he only receives compliments about the great work and treatment. Mr. Jankowski stated the City has also partnered with CHC and they have a drive-thru vaccination site. Mr. Jankowski believes CHC has administered over 40,000 vaccines and Stamford Health has administered over 70,000 vaccines in the City of Stamford. Mr. Jankowski said the only limiting factor would be the number of vaccines that the City is receiving.</li> <li>• Mr. Jankowski stated the Department has a mobile van which was taken out yesterday. Mr. Jankowski said that expect to have some plaque art on the side which reads ‘City of Stamford, COVID-19 Vaccination Program’. Vaccination’, meaning going out into the Public and getting vaccines to the people out there.

- Ms. Parry asked Mr. Jankowski what van do ‘we’ have because she was under the impression that ‘we’ had a van that ‘we’ got rid of.
- Ms. Parry asked Mr. Jankowski who owns the van?
- Ms. Parry asked for clarification regarding if this is the van that Health Department owned/had.
- Mr. Jankowski said with the Mobile Vaccination Program what the City really would like to do, is use the Johnson & Johnson vaccine. Mr. Jankowski explained the reasoning being was it’s a one dose vaccine, which he believes would be better received by those who have limited time to get the vaccine because of work or family requirements. Mr. Jankowski stated that the City is trying to increase their numbers of the Johnson & Johnson vaccine.

- Mr. Jankowski clarified ‘we’ have a sprinter van. Mr. Jankowski said he doesn’t want people to think the van is going to be like a Mobile Food Truck, where people are going to maybe go inside the van. Mr. Jankowski further explained the vision of Dr. Calder is that the van would carry everything that’s necessary and a tent would be setup outside to vaccinate individuals.
- Mr. Jankowski stated the City of Stamford owns the van.
- Mr. Jankowski responded it is. Mr. Jankowski said there were two (2) vans, one of which was like a mobile home type of van. He explained that van was too cumbersome, very difficult to get out and had special requirements to driver (CDL Driver’s License). Mr. Jankowski said the van that they have now is a regular van which has no special requirements to driver.

- 911 Communications

- Mr. Jankowski reported there are two locations for Stamford Health; one at the main campus and the other at Elmcroft. Family Centers has vaccines. Optimus is getting out approximately 400 vaccines a week and are asking for more vaccines from the State.
- Mr. Jankowski said there is a program going on right now to vaccinate the seniors and High School. CHC is currently vaccinating seniors in High School because of their potential to participate in senior school events at the end of the school year.
- Mr. Jankowski stated a lot of technology has been updated in 911 Communications Center. He said ‘they’ are getting the fullest functionality that they’ve ever had in the City. Mr. Jankowski said Joe Gaudett, Director of 911, has made some adaptations that has helped bring the Center to where it needs to be.
- Mr. Jankowski said another piece of technology that 911 Communications is using is a program called Carbine. He said Carbine is a program where a Dispatcher, where if someone calls and states something were to happen, the Dispatcher would be able to pull the coordinates to get the exact location of where the person is. Mr. Jankowski reported approximately two (2) individuals were saved as a result of having this program.

Mr. Jankowski reported Carbine gave a presentation on this yesterday and it may have some benefits pertaining to Mental Health Responses.</li><li>• Ms. Parry asked if a caller had to give permission for Dispatch to pull the exact location, how that would work with Mental Health issues.</li><li>• Mr. Jankowski said next month the City is bringing on a Social Service Worker at the Police Department, fulltime, forty (40) hours a week and be on-call to respond when they are there to any type of mental health call, but also to make sure that the individual has continuum of care.</li><li>• Dr. Getreuer asked Mr. Jankowski if the Social Service Worker would be under the Police Department or the Health Department.</li><li>• Mr. Jankowski said the City is looking to hire more individuals for the Fire Department but like all other departments the individuals currently working has really stepped up.</li><li>• Mr. Jankowski said illegal dumping is something that is high on his list. some reason the City is seeing a lot more illegal dumping and he is receiving numerous complaints.

- Mr. Jankowski said the City has brought on Citation Officers, who fall under the Public Safety, Health & Welfare Department, as of August 2020. Mr. Jankowski stated Frank Fedeli is the Chief Citation Officer, who was going out for COVID enforcement, as well as the Environment Inspection. Mr. Jankowski stated that Frank Fedeli was addressing a lot of the areas that Health doesn't have the authority.
- Mr. Jankowski reported only three (3) locations have been closed down since the beginning of the pandemic because of overcrowding, failure to comply with Governor orders, not wearing masks, serving alcohol with no food, etc.
- Dr. Getreuer had asked Mr. Jankowski a question on MRC, stating it appears more MRC Volunteers are needed and if that is the case, can anything be done through Public Safety or the Health Department to advance the training of more MRC people.

- Mr. Jankowski responded that's one of Dr. Calder's head projects, stating she loves the MRC and the fact they are volunteering. Mr. Jankowski said right now everything is just overwhelmed and they do seek to increase the ranks. Mr. Jankowski said normally they have the Citizens Public Safety Academy, and that's usually their recruitment effort but they did not have one during the COVID-19 pandemic because it would be tough to get everyone in the same room. Mr. Jankowski said the next recruitment wouldn't be until September, and they will evaluate then.
