

#### CITY OF STAMFORD POLICEMEN'S PENSION TRUST FUND BOARD

A Regular Meeting of the Stamford Police Pension Board of Trustees was held on Tuesday, March 9, 2021 at 5:30 p.m.

Present at the meeting were Lt. Michael Noto, Officer Jessica Bloomberg, Commissioner Timothy Abbazia, Commissioner Frank Mercede and Mr. Michael Berkoff. Also present were Thomas Deegan of Clearshares, LLC; Attorney Anthony Macleod and Donna DeVito, Recording Secretary.

The meeting was called to order at 5:32 p.m. by Lt. Noto.

# Approval - Meeting Minutes from February 9, 2020

Lt. Noto stated that the Board approved that one Officer will receive a disability pension of 75%, plus pension buy-out enhancements, for a total of 84.15%.

Lt. Noto reported that notification was received that an additional \$2MM was invested in the Iron Triangle Offshore Fund Ltd. on March 2, 2021.

#### **New Business**

### **Peoples Bank funding**

Lt. Noto reported that Peoples Bank requested \$100,000.00 to fund the final payment for the paying agent account.

A Motion was made by Mr. Berkoff, seconded by Commissioner Abbazia, and approved unanimously, to wire \$100,000 to the Peoples Bank paying agent account as the final payment.

#### Fund Review

Tom Deegan distributed the monthly financial statement and a Flash Report for February 2021 that included the Fund's asset allocation and 12 month rolling graph. He reported that as of February 28, 2021, the Fund's assets were \$226,099,383, the monthly performance was 1.27%, quarter performance to date was 1.59%, year-to-date performance was 1.59% and fiscal year performance to date was 12.12%. He reported that the first 25 days of the month were strong and in the last few days there was a sell-off. However, overall it was a pretty good month. He advised that the last contribution payment from the City was received and net pension payouts continue to be approximately \$1.4MM each month. He reported that \$2MM was added to the Iron Triangle Offshore Fund but overall, the allocation to hedge funds continues to be decreased. Mr. Deegan expressed his concerned about inflation as the recovery continues but felt that the Pension Fund was in a good place and did not recommend making any measurable changes to investments at this time.
