**Public Comment Opportunity on Current Applications**

**Review of Current Applications**

**Traffic Division** – traffic monitoring without recording at 75 locations.

**Downtown Special Services District** – 7 locations applied for, at Level 2 surveillance level.

**Illegal Dumping**– Police Department would like to add an additional street to that application. Due to the Surveillance Level of the application, all members need to be present to move forward with a vote. Mr. Jankowski recommended that it be taken up at next meeting.

#### **Discussion of Policies and Procedures Manual**

Mr. Jankowski handed out copies of the Manual with proposed changes highlighted, and the Committee reviewed and discussed.
