Clemon Williams - For the Fire and Police Pension Funds it has been common practice for individuals to take a normal retirement, once their disability is approved the pension is recalculated.

Burt Rosenberg – We are only asking for an advisement opinion. The decision is for the Trustees to decide.

Mary Lou Rinaldi – To Burt – If the lawyer comes back and says the Plan does allow it. If the Board decides not to go that route, do we open ourselves to any kind of legal issue?

Burt Rosenberg – I don't think so.

Burt Rosenberg made a motion to appoint Attorney John Jacobson of Reid and Riege. The motion was seconded by Joseph Caruso. The vote was 5-0 unanimous.

Burt Rosenberg made a motion to approve the following wording - Is an employee who applies for and is granted a normal, vested or early retirement precluded from subsequently applying for a disability retirement under the Classified Employee Retirement Fund? In addition is an employee precluded from simultaneously filing a request for a normal, vested or early retirement? The motion was seconded by Joseph Caruso. The vote was 5-0 unanimous.
