Acting Chairperson Randy Skigen called the meeting to order at 9:05 a.m.

Dan Collelouri – Agreements were done in good faith. Employees relied on what was in the agreements.

Tim Beeble – When the City eliminated a position or someone was laid off, the duties were assigned to another employee. A stipend was given to an employee for taking on extra duties.

Deborah Gorenflo – Regarding Alfred Gorenflo's retirement – Wallachs Point trench caved in and he was injured. I would ask this Board to approve his retirement.

Peter Privitera – Mayor Malloy asked me to take on the duties of Purchasing Agent. Mayor Pavia asked me to continue taking on the duties of the Purchasing Agent and asked the Human Resources Department to do a Memorandum of Understanding outlining my responsibilities and benefits that I would receive. I then took a job with another municipality and went down to the Human Resources Department to see what my benefits would be when I retired. I was given a term vested form. There are other

employees who agreements were done for. The City saved money both on the salary and benefits of a new employee. I ask that Mr. Rosenberg recuse himself on the vote for my pension. Mr. Rosenberg had a conversation with Dan Colleluori and Mr. Rosenberg told Dan (I can't say verbatim) that he was going to blank Mr. Privitera like he blanked Mr. Ruszkowski.

Burt Rosenberg – I did not make those comments. What I said to Mr. Colleluori was that Mr. Privitera suggested that Mr. Ruszkowski be laid off and that he would take over the responsibilities. The stipend went from \$3,500 to \$8,000 to \$15,000.

Dan Colleluori – I had a conversation with Burt who said screw him he screwed him.

Alvin Siegartel – What is happening to the funds that Fred Manfredonia took? Mr. Privitera is entitled to his pension. The new mortality tables go into effect in 2016.
