CALL TO ORDER

The meeting was called to order at 12:45 pm by Chairman Rudy Marconi.

PUBLIC PARTICIPATION

Tracy Alston from Eversource gave an update on the availability of energy assistance programs for customers. She wants the public to be aware that there are scammers posing as Eversource employees trying to get personal information. There are reports that they are using technology to have the caller ID come up as Eversource. She would like to public to be aware that Eversource will never ask for a debit card over the phone and shutoff notices are always issued in writing.

ACTION ITEMS

Approval of 02/18/2021 Minutes: After review and on a motion made by Sherman First Selectman Don Lowe and seconded by Bridgewater First Selectman Curtis Read the minutes of the 02/18/2021 meeting were unanimously approved.

LOTCIP Adjustment

After a presentation by WestCOG Senior Project Manager Kevin Mahoney, a motion to endorse an additional project sponsored by the City of Stamford, known as the Shippan-Harbor-Magee Roundabout was made by Westport First Selectman James Marpe seconded by Stamford Mayor David Martin and unanimously approved.

Quarterly Financial Report

After review by Redding First Selectman Julia Pemberton, and on a motion made by New Milford Mayor Pete Bass and seconded Bethel First Selectman Matt Knickerbocker, the quarterly financial report was unanimously approved.

INFORMATION ITEM

Extension of gubernatorial Executive Orders

WestCOG Executive Director Francis Pickering gave an update on the Extension of gubernatorial Executive Orders. The public health and civil preparedness emergencies that were enacted to enable the state to provide an adequate response to the ongoing COVID-19 pandemic. The declaration will remain in effect through May 20, 2021.

ARP funding use (regional broadband)

Francis gave an overview of the potential use of funds through the American Rescue Fund to improve broadband in the area.

Water testing (regional approach, PA 12-197) Francis gave an overview of the reports recently released by the U.S. Geological Survey regarding high levels of Uranium and Arsenic in private wells in the region. While known to be a serious health concern, there is currently no requirement through local health departments to test for these pollutants. Frances suggested consideration of COG in conjunction with the local Health districts roll out a regional testing program to interested communities.

State and Federal update

Francis gave an update. There is potential for new revenue for the state from Online Gambling and Marijuana. Federal updates on the infrastructure package transportation reauthorization have not been released. The 2020 Census is still ongoing.

Regional services update

Francis gave an update. The Budget for the fiscal year 2022 is currently being worked on. Ideas from the region are welcomed as topics to consider.

OTHER BUSINESS: Rudy discussed the fee for service model of funds to cover the cost of a Regional Engineer as discussed at the Executive Committee Meeting.

WestCOG Regional Deputy Director Mike Towle shared comments from Jennine Lupo from Congresswoman Jahana Hayes office, about the ARP tax credit available for Small Business's providing time off for their employees to get the Covid-19 vaccine.

ADJOURNMENT

The next COG meeting will be held on Thursday, May 20th. On a motion Duly made and seconded, It was voted unanimously to adjourn the meeting at 1:35 pm.

RE: WCEDD: EDA Planning Partnership Grant

Grant description

EDA has invited WestCOG to apply for a grant through its Partnership Planning Program, which funds Economic Development District (EDD) activities nationwide. Grant funds could be used to:

- Expand the activities of the Western Connecticut Economic Development District (WCEDD)
- Enhance collaboration with economic development partners in the region, potentially including southwest Connecticut's nascent Next-Generation Regional Sector Partnership (focusing on tech-enabled, data-dependent businesses)
- Revamp the Comprehensive Economic Development Strategy (CEDS), including required annual reports and five-year updates
- Monitor economic indicators and track impact of economic development activities
- Pursue opportunities for economic development funding to the region

An EDA Partnership Planning grant would provide WestCOG with dedicated funding stream for economic development activities, substantially increasing capacity in this important area and enabling the organization better to address the priorities of WestCOG and WCEDD.

Financial impact

The grant award is for up to \$70,000 in federal funds, with a 50:50 local cost share requirement. WestCOG may be able to satisfy this requirement at no financial cost to the COG through ongoing joint projects with other regional partners; WestCOG's draft Regional Services Grant Spending Plan budgets \$70,000 (of currently unmatched funds) as a fallback should such an arrangement prove inviable.

Next steps

COG authorization to apply to the grant is recommend prior to the deadline of June 4.

Background

Following the U.S. Department of Transportation, WestCOG's largest funder is the Connecticut Office of Policy and Management (OPM). WestCOG's OPM funding comes in the form of a Regional Services Grant (RSG) to be used for the provision of regional services, particularly those that result in cost savings to municipalities and local taxpayers.

In order to receive these funds for SFY 2022, WestCOG must submit a spending plan for the use of these funds to OPM by July 1, 2021.

An RSG spending plan for state fiscal year 2022 (July 1, 2021 thru June 30, 2022) is below. The plan, which has been recommended by the Executive Committee, anticipates that RSG funds would be expended as follows. The plan may be adjusted by the Executive Committee throughout the year as needed (for instance, should funding or project costs, scope, priorities, or viability change).

Thank you for following progress of Phase II of the Resilient Connecticut planning process. We have enjoyed presenting Resilient Connecticut to you at the monthly WestCOG meetings of fall 2020 and winter 2021. Now that spring has arrived, we are pleased to present another project milestone.

- The information sheets following this page include the following:
 - ✓ The "Terms to Understand" page provides a list of terms and their meanings on the left side, and a list of project resources with hyperlinks on the right side.
 - ✓ Each potential regional adaptation/resilience opportunity area identified in the WestCOG region is described on an individual page. Regional adaptation/resilience opportunity areas are the geographic locations that our team has identified based on overlays of flood vulnerability, heat vulnerability, social vulnerability, zones of shared risk, and regional assets and infrastructure.
- Here are some helpful hints when reviewing information sheets:
 - ✓ The numbers associated with the flood, heat, and social vulnerabilities are <u>relative</u> scores between zero and one. This means that a score of "0.9" in one opportunity area demonstrates higher vulnerability than a score of "0.5" in a nearby opportunity area.
 - ✓ The ID numbers for the zones of shared risk include a four-digit watershed identification number developed by the State. For example, "7300" is the Norwalk River watershed.
 - ✓ The "areas of planned development" have been gathered from community plans, but the names that we selected for these information sheets are a work in progress. We plan to revise these as needed.

 - ✓ Please register for the Resilient Connecticut workshop scheduled for WestCOG on May 26, 2021 at 1 PM. We plan to discuss these potential regional adaptation/resilience opportunity areas.

Potential Regional Adaptation/Resilience Opportunity Areas

Terms to Understand

Considerations	Definition
Flood Vulnerability	A contributor to climate risk associated with flooding, this is a combination of flood exposure, flood sensitivity, and flood adaptive capacity.
Heat Vulnerability	A contributor to climate risk associated with heat, this is a combination of heat exposure, heat sensitivity, and heat adaptive capacity.
Social Vulnerability	Factors such as poverty and lack of access to transportation that may weaken a community's ability to prevent losses during a disaster.
Zone of Shared Risk	Areas that face common challenges already, or caused by climate change, and therefore risks are shared among or between groups of people that may have different perspectives and priorities for resilience.
Regional Infrastructure	Infrastructure that serves more than one community; or is important to a region.
Area of Planned Development Present	Areas identified in POCDs and RPOCDs for a variety of development and redevelopment.
Federal Opportunity Zone	Opportunity Zones provide tax benefits to people and companies with the goal of investing in urban areas.
Transit-Oriented Development Area	Supports creation of compact, pedestrian-oriented, mixeduse communities centered around train or transit systems.
