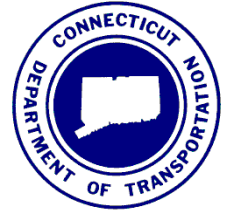

Notice of Public Hearings

The Connecticut Department of Transportation (CTDOT) will conduct virtual public hearings on rail service and fare changes that were previously made in response to the COVID-19 pandemic, as well as the proposed elimination of the Mail & Ride fare media. The hearings will also cover proposed service changes to CTtransit bus service and minor fare changes on two CTtransit Express bus routes.

Service changes to the New Haven Line, New Canaan Line, Danbury Line, Waterbury Line, Shore Line East, and Hartford Line were previously implemented on an emergency basis. No further reductions in rail service are expected. Proposed bus changes include service changes to CTtransit Express bus service to/from Hartford and CTtransit New Haven local service; and minor fare changes for Hartford Express routes 950 and 912.

At these hearings, CTDOT will provide information and accept public comments on the service and fare proposals and the Service and Fare Equity (SAFE) analysis. The SAFE analysis evaluates the proposed changes to determine if they will cause a disparate impact to minority persons or a disproportionate burden to people with low incomes, as defined by the FTA Title VI circular. **The proposed service and fare changes may be viewed on the Department's website at www.ct.gov/dot/proposedtransitchanges** and will be available as of Thursday, April 29, 2021. The public comment period will run from April 29 to May 28, 2021.

Due to the ongoing COVID-19 pandemic, the hearings will be conducted virtually via Zoom's online platform and toll-free conference call feature. The public hearings will also be live streamed via Microsoft Teams Live Event and YouTube. All public hearings will be recorded and published online for later viewing.

SWRMPO FFY 2021-2024 Transportation Improvement Program (TIP)

Background: The FFY2021-2024 South Western Region TIP was endorsed by the MPO on October 15, 2020. The TIP was incorporated into the larger Statewide TIP, which was approved by USDOT and EPA on January 26, 2021.

TAG Action Requested: Review and support TIP amendment endorsement by MPO.

Amendments #2021-0520

0301-0195: New Haven Line- Station Improvement Program- Darien Station

The CTDOT-requested amendment would add a new project to the TIP in the Town of Darien. Improvement to the Darien Station on the New Haven Line would include construction of new platform sections, ADA platform upgrades and routing signage, as well as replacement of the grounding and bonding system. Construction for this project is scheduled for 2021. The project total is approximately \$45 million with no local match.

0300-0196: New Haven Line- Scour Rehabilitation Project

The CTDOT-requested amendment would provide funding for rehabilitation activities for Bridge 08022R in Darien and Bridge 08207R in Wilton along the New Haven Line in the SWRMPO, as well as Bridge 08086R in Milford and Bridge 08268R in Seymour. Scour is erosion of the soil at or near the substructure. To rehabilitate the bridge's scour mitigation, CTDOT will be performing full repairs of the structures to raise the condition rating to a state of good repair. Construction for this project is scheduled for 2021. The project total is approximately \$8 million with no local match.

MPO Action Requested: review and endorse FY2022 and FY2023 UPWPs for HVMPO and SWRMPO, contingent upon administrative and technical adjustments to address any remaining CTDOT and USDOT comments. Draft copies have previously been circulated to MPO and TAG members for review on March 16th and May 14th.

Overview: An UPWP is a federal requirement for MPOs, outlining planning priorities and activities to be carried out during a defined period of time, in this case for a two-year period beginning July 1, 2021. A USDOT and CTDOT approved UPWP allows the MPOs to receive funding to carry out the transportation planning process and remain eligible for receipt of federal-aid project funding in the region's municipalities.

The UPWP includes a mix of administrative and technical activities, addressing both federal requirements and areas of regional interest. Administrative examples include processing Transportation Improvement Program (TIP) amendments, meeting preparation and financial grant management, whereas technical activities may include data analyses as well as support for corridor studies.

Work Program Components: CTDOT's guidance identified the core requirements and activities, many of which are similar to the previous UPWPs, endorsed by both MPOs in May of 2019.

This includes federal emphasis areas such as compliance with MAP-21 and the FAST Act provisions. These are authorizing legislation for federal transportation programs and funding, which contain specific requirements that must be adhered to.

Planning activities continue to include efforts to transition to performance-based planning. Other activities include: completing an update of the Long-Range Transportation Plan; updating the Public Participation Plan; promoting cooperation and coordination across MPO and state boundaries; continuing the region's Congestion Management Process (CMP) analyses; management of the TIP; and continuing tasks related to transit planning, multi-modal mobility and connectivity, and freight planning.
