The meeting was called to order at 1200 by Chairman Golden.

Chairman Golden introduced himself and took roll call. All Board Members were present.

#### **Approval of Previous Minutes**

Chairman Golden distributed the minutes of the March 15, 2021 regular board meeting. No one on the Board had comments or changes.

An application for a Firefighter with 22 years of service, for a REGULAR PENSION at 60.17%, effective April 1, 2021, was presented.

A **MOTION** was made by Trustee Fountain and seconded by Trustee Micalizzi at 1205 to accept the pension. Motion **PASSED** unanimously.

An application for a Captain with 32+ years of service, for a REGULAR PENSION at 81.50%, effective April 26, 2021, was presented.

A **MOTION** was made by Trustee Anderson and seconded by Trustee Fountain at 1206 to accept the pension. Motion **PASSED** unanimously.

An application for a Firefighter with 25.69 years of service, for a REGULAR PENSION at 69%, effective May 1, 2021, was presented.

A **MOTION** was made by Trustee Anderson and seconded by Trustee Micalizzi at 1210 to accept the pension. Motion **PASSED** unanimously.

#### **Update on Address Verification Campaign**

Trustee Micalizzi presented information provided by Barbara Murphy, who had been heading the task. Out of the 231 initial letters mailed out to pensioners, there were 217 responses. Of the 14 "no-responses", after our previous months meeting, Barbara had received an additional 6 replies, bringing the total number of outstanding "no contact" recipients to 8. While the process has been slowed this previous month due to Barbara's involvement with the SFD hiring process, the plan is to reach out directly to the remaining 8 for verification.

#### **Investment Update**

John Oliver Beirne reviewed the current performance of the Fund.

Beirne is continuing to move the Fund investments to fall in line with the investment policy guidelines. The broad policy guidelines for the Fund are in range. Within sub-asset classes, the Fund continues to be overweight in U.S. equities which are outperforming their benchmarks, and underweight in international equities. Trustee Gold requested that Beirne sends cluster charts to the Trustees when the information becomes available. Additionally, Trustee Gold asked if an attribution analysis could be delivered to the Board on a regular basis. John Oliver mentioned that this information used to be provided to the Board, but it had been requested to be removed in recent years.

Beirne's presentation concluded with an overview of the upcoming Board of Flnance presentation.

#### **Board of Finance Meeting**

A discussion was held to outline talking points for the upcoming Board of Finance presentation being attended by Chairman Golden and John-Oliver Beirne. The presentation is limited to 20 minutes, and there will be a conversation on the current state of the Fund, as well as forward looking plans. There will be an emphasis on increased fund performance highlighted in the discussion.

#### **Pension Trust Agreement Document Update**

Chairman Golden updated the Board on the ongoing project with Attorney Underberger updating the 1971 Pension Trust Agreement and the 1997 document. Chairman Golden asked for a member of the Board to serve as the "project lead" with the ongoing process, and Trustee Anderson agreed to undertake that role.

#### **Investment Custodian and Pay Agent Services RFP**

Four finalists remain for the above mentioned services. The final determination on the chosen vendor will be made soon. The Stamford Firefighters Pension Fund is under no obligation to use the chosen vendor that the City picks.

#### **Other Business**

Trustee Anderson requested of the Board that the Union be allowed an alternate Trustee, as has been common practice in the past. Firefighter Andrew Siano, who was present on the meeting, was welcomed by Chairman Golden to the group.

#### **Executive Session**

A **MOTION** was made by Trustee Fountain to enter Executive Session at 1336 and seconded by Trustee Gold. Motion **PASSED** unanimously.

A **MOTION** was made by Trustee Fountain to end Executive Session at 1347 and seconded by Trustee Gold.. Motion **PASSED** unanimously.

#### **Next Meeting**

The next **Regular** meeting will be scheduled for **Tuesday**, **May 11**, **2021 at 1300** in the Commissioner's Conference Room at Fire Headquarters or via teleconference.

#### **Adjournment**

A **MOTION** for adjournment was made by Trustee Micalizzi and seconded by Trustee Anderson. Motion **PASSED** unanimously at 1355 hours.
