### **OLD BUSINESS:**

➤ Update on 50/70 Baseball.<sup>4</sup>

Mr. Newman gave a report on Babe Ruth and the Little Leagues trying to meet to work out field schedules and an update on the grant funding for Northrup Field.

Mr. Tedder provided some insight from a conversation he had with a long-time Little League manager/ coach and former umpire stating that baseball participation is very low and the Commission should try to support appropriate programs to increase participation.

➤ <u>Cubeta Stadium</u>: Marc Fraioli - Senior City League (formerly Westchester Rockland Wood Bat League). Proposal for men's baseball 19 and over. Laurie Albano, Superintendent of Recreation, will provide an update.<sup>5</sup>

Ms. Albano provided an update and recommended extending sanctioning through next year. Once we have the Consultant's Report, a strategic plan can then be put together to schedule field time for Mr. Fraioli's organization.

Mr. Newman stated Mr. Fraioli should submit a request for sanctioning and a roster for next year so discussions could take place over the winter.

Mr. Tedder suggested that some dates should be provided to give the organization a chance to play and provide exposure to Stamford residents to increase participation.

Mr. Newman allowed Mr. Fraioli to speak and he expanded on the suggestion by Mr. Tedder.

After considerable discussion, it was decided that Mr. Fraioli will submit a request for sanctioning and possibly attend the February meeting for further discussion.

## **STAFF REPORTS**:

➤ Laurie Albano, Superintendent of Recreation: Recreation Update.<sup>6</sup>

The following Staff Report was submitted and discussed by Ms. Albano:

[Begin Report]

#### **RECREATION:**

- Camps busy: One (1) strep case, one (1) head stitches, one (1) broken arm, two (2) DCF child abuse cases and one (1) expulsion so far. Otherwise, majority of them are running well. Regular numbers still down at 879; below our typical 1,000+.
- Beaches busy. Great life guard team this year. Lead Supervisors and great work by Meg.
- Weather has been a challenge for camp, leagues and beaches.
- Adult Leagues all well except for rain.
- Tram all good up until last week. Fuel pump blew but back in operation. Good staff.
- Working on fall programs and brochure; sent to the printer.
- Banner ad "Your Ad Here" up at C1 softball field to entice advertisers and build revenue.
- PAR in for Bobby Pentino, Recreation Supervisor replacement. Bobby left for a similar position in Norwalk.
- Baseball consultant in process. Good leads on consultant organizations. Will request from each a resume and set up final selection committee. Hope to get a selection made by end of August/early September.
- New payroll system and Kronos issues. Some seasonal camp staff not paid since late June. Tough time to start a new system with so many seasonal staff hired, but they did. We cannot keep telling these folks they do not have a paycheck. We finally have it rectified.
- Buses and Driving Schools at Cove Island Park lot an issue. Emailed Director McGrath.

#### **TERRY CONNER'S RINK:**

- All Capex on track. Current A&V system shut down to come back mid-August.
- Roof leaks have occurred, but subsequently patched again. New roof needs to be factored into the overall financial model soon. Capex budget begins in fall.
- Camps light in numbers due to Board of Education free summer program, but 40 per session average and going well. Fifty (50)+ in next few weeks.
- Olympia brand ice re-surfacer is down and has been for some time now. First year model bought new in 2013 for \$190,000. Has always been a lemon; lots of repairs. Working now on our options with Olympia Corp. Potential fix here. Either truck it back up to Canada, or take our lumps \$ wise and trade it in for a new machine.
- Rink Operator position posted and certification list being prepared by Human Resources. We were waiting on the new fiscal year to fill it. Will be a welcome much needed hire for Ken.
- Same seasonal pay issues here too, mostly wrong rates. Getting fixed.
- Going to give the concession stand another shot with an RFP for a live food vendor. Will adjust specifications to only prime-time hours for prime season of September to March only. Have also reached out to all local delicatessens and restaurants directly sending them the RFP.

Ms. Ruijter and Chief Mann made a presentation to the Commission explaining how the idea for the PowWow came about from discovering and preserving the original deed for the City of Stamford which confirms the presence of the Lenape Indians in Stamford. Ms. Ruijter explained that this could possibly be an annual event that could also be included in the curriculum of the education system.

After considerable discussion, the Commission decided to *TABLE* this item to the August 18, 2021 meeting so discussions with other City agencies (i.e. Police, Fire Marshal, Director of Operations) could take place and perform further due diligence.

- New Fiscal Year 2021-2022: Requisitions are entered for all programs for purchase orders.
- Upcoming Capital Project submission projections FY 2022-2023.
- Park Attendants Update: Have received many compliments with all sites and attendants that are assigned during Friday through Sunday tours. Adding golf carts to assist with convenience/access to patrol Cove Island Park.
- Hurricane preparation tabletop exercise with City EOC/Operations teams.
- Vaccine sites are still active in multiple parks and have been redirecting on a revolving schedule. Park employees are coordinating setup and breakdowns for daily activity.
- Cove Island Park Red Brick Building receiving a facelift and exterior paint job.
- West Beach Pavilion: New roof and canopy repair upgrade is currently being done.
- Barret Park Drainage Project near playground after heavy rain held up great and drained properly.
- Courtland Avenue Park (Dog Park) bathroom facility received exterior upgrade where we replaced rotted wood and painted.
