Personnel Update:

Administration and Operating

The Stamford Police Department has four employees out with COVID. Three Officers and one civilian.

A/C DeRubeis mentioned that the third suspect in a homicide was apprehended and arrested. Officers from the BCI unit will be commended next month. Five Sexual Assaults and a suicide that began as a homicide in Milford, CT. Victim/Suspect executed ex-girlfriends boyfriend and was about to execute her but she was able to run away. The suspect drove to Stamford and committed suicide in Cummings Beach. Intel went out very quickly and scene was locked

down. NOC officers apprehended robbery/Assault on July 9 at Town Center after info went out NOC officers saw suspect on the East Side and detained him.

A/C Redd informed Commission that recruiting is open for the SPD. Training and COPS units has their first booth set up at the craft fair on Bedford Street.

Community Engagement

New to the department is the Shoulder-to-Shoulder initiative launched four weeks ago on the West Side. Several city agencies and the police department have combined their talents to bring help to the people who need it.
