➤ Laurie Albano, Superintendent of Recreation: Recreation Update.

The following Staff Report was submitted and discussed by Ms. Albano:⁴

RECREATION:

- Fall program brochure is online both City and Recreation websites. Registration begins on Sept. 2, 2021.
- Summer day camps have ended.
- Beaches still busy. Reduced swim areas and schedule due to losing Lifeguards.
- Adult Leagues and weekend tournaments all running well. Summer season winding down, in playoffs.
- Tram will run through Labor Day.
- Recreation Supervisor replacement. Recruiting now.
- Baseball is down to four (4) consultant organizations. I set up a Selection Committee meeting on Tuesday, August 31, 2021 with Mark McGrath and Kevin Murray. Hope to get a selection made shortly thereafter.
- Recreation field use application and policies needs a review. Meg and I will be doing soon and will separate the field and tournaments into two applications. Need to discuss payment policy and weekend tournament staffing.
- Buses and Driving Schools at Cove Island Park lot an issue. Emailed Director McGrath and Kevin, and it has now stopped.
- Setting up September strategic planning meetings with Recreation Staff. Time to review and do a deeper dive into its mission, staffing and goals.
- Working on a new credit card processor that integrates with our point of sale/registration software.
- Will be working very soon on the extension of the Star Center lease with financial modeling assistance from Laura Burwick, Special Assistant to the Mayor.

TERRY CONNER RINK:

- All Capex and pre-ice shutdown for A&V system done. Ice started take down process this past Sunday. Next phases of capex includes the new compressors and electrical control system. Hope to re-open the rink on Sept. 7, 2021 if all goes well.
- No new roof leaks after most recent patching. New roof needs to be factored into the overall financial model soon. Capex budget begins in fall.

- New fire alarm system in process and will tie in to the new Ammonia system.
- Camps numbers shot up the last two weeks of camp due to BOE free summer program being over.
- Olympia brand ice re-surfacer Rep will be here on Friday to survey the machine. First year model bought new in 2013 for \$190,000.00, has always been a lemon; lots of repairs. Working now on our options with Olympia Corp. Potential fix here, trucked back up to Canada, or take our lumps \$ wise and trade it in for a new machine.
- Rink Operator position posted and still waiting on certification list being prepared by Human Resources.
- I have re-written the DRAFT specs for the concession stand again to give another shot at an RFP for a live food vendor. Hope to have it out to purchasing soon.

➤ Kevin Murray, Operations Manager - Parks & Facilities: Parks Update.

- Vaccine sites weekly have been active with Stamford Parks and crew has been doing a fantastic job daily for set-up coordination.
- Ordinance for Public hearing and final adoption: Organic Field Program has a public meeting on Tuesday 8/24 within the operations Committee
- Greenwich Organic Site meeting: Visited Greenwich and met with Superintendent of grounds Tim Coughlin to view grounds that have been organic for the last 10 years of the program, major take a ways was dedicated trained staff and education of the product, over management of the properties which includes mandatory shutdowns, land supplies to support the organic plan and most importantly funding to incorporate the program
- Looking to set up Site meetings with Branford CT and Cheshire to view organic model- keep you posted
- Away with Geese product will be installed this coming week within the Cummings Park/Beach property- attached is the Placement map of the units we are installing for the Test Pilot
- Youth Baseball/softball leagues and tournaments are now widening down
- Mayors Mask Mandates in Stamford Parks are to be followed- attached Memo indicates for City parks air locations, the mask mandate is an effect for the mass gatherings over 100 individuals as the event pertains to outdoor settings
- Board of Representatives, Parks & Recreation Committee meeting scheduled for Tuesday, August 31, 2021 will discuss eliminating beach Pass Charges for Stamford Residents. This was submitted by Representatives John Zelinsky (District 11) and Megan Cottrell (District 4).
- Reconnecting Barret Park group has been meeting monthly and master plan architect proposals are now being reviewed for capital submission this coming for future upgrades
- Cove Island upgrades to Playground Gazebo, Picnic shelter and Red brick maintenance and bathroom building.
- Vaccine sites continue in to the Fall season within Park locations thus working w administration to hold (6) dedicated seasonal employees to ensure continues set up and break downs throughout as the last day annually for seasonal currently is 10/15/21.
- Bathrooms within major parks to remain open until November 15, 2021 as we have been experiencing warmer weather over the last several years and with staff resources we have additional seasonal employees and are proposing to leave major bathroom locations open/cleaned. Normally bathrooms would be closed on October 15, 2021, which is the last day for the seasonal employees. Porta-johns will be stationed for use in the smaller parks as normal.
