1. Call to Order and Roll Call

R. Barocas called the meeting to order at 5:02 pm. A quorum was present.

2. Approval of the August 23, 2021 Finance Committee Meeting Minutes

The August 23, 2021 meeting minutes were approved.

3. June 2021 financial update & update on July receivables/arrears (Mark T)

M. Turndahl provided the July 2021 accounts receivable balance update: Sewer use receivable balance was \$2.48 million down from July 2020 balance of \$3.06 million, over \$22 thousand was applied to the oldest receivables and the average collection rate for 2021 was 99.35%, up from 98.35% reported for June 2021. Sewer use and sewer connection and assessment cash collections through July 2021 was behind the previous July by \$68 thousand. He then provided details to the June 2021 Income Statement reporting a net income of \$5.3 million, ahead of budget by \$5.0 million, a pooled cash balance of \$15.0 million and a reserve account of \$13.7 million.

4. FY 2021 year-end close and Auditors year-end audit plan (David Yanik)

D. Yanik reported that the year-end close was proceeding as planned and the period 12 trial balance is expected to be turned over to the Auditors after Labor Day. M. Turndahl stated that he is still working on the requested audit schedules and expects to finalize the WPCA trial balance by the requested due date.

5. Discussion FY2021-22 User Charge (Mark Turndahl)

M. Turndahl provided a brief over view of the new rate discussed at the July 19, 2021 meeting: Based on an adjusted annual consumption of 4,232,854 CCF, an assumed collection rate of 97%, accounting for revised budgeted revenues for Nitrogen Credit and interest income (down \$300,000 and \$75,000) and allowing for a 115% senior debt coverage ratio (requiring \$616,500 additional revenues) the new sewer use rate was calculated at \$5.26 per CCF, a \$.10 and 1.88% increase.
