3. SAC Grant Application Review

 - i. One for the State of Connecticut Arts Endowment Fund Grant, and the other for the Arts Project Grant from the National Endowment for the Arts.
 - ii. Chair Colatrella asked that Mr. Varamo read through all the examples of what these grants are allowed to fund, and what they are not allowed to fund.
 - iii. The commissioners discussed each guideline and decided if it applies to the SAC grant or not.
 - iv. Mr. Varamo stated he would send the commissioners a compiled list of the SAC Funding Guidelines based on the commission's review the state and federal grants.
- b. The commission asked for an updated timeline for the 2021 SAC grant, which Mr. Varamo said he would send via email.
- c. The commission agreed that future SAC grant funding is contingent upon the successful completion of previous SAC grant programming.
- d. Ms. Cuscuna suggested that the commission look at incorporating a more standardized grant review and scoring system based on the State of Connecticut's Regional Initiatives (REGI) Grant. This numeric scoring system would take into account a program's artistic merit, a social equity component, accessibility of the programming, and recipient reliability. Chair Colatrella asked if Ms. Cuscuna could put together a sample rubric for the commission before the next meeting on September 15. Ms. Cuscuna stated she would complete it before then and email it to all the commissioners.
