3. Act on pending Retirement Resolutions:

Motion: Motion was made to approve a 74% Regular pension, effective August 20, 2013, 5:00pm, to Fire Mechanic Thomas Mardi as outlined in the pension calculation form. Motion passed: 4 approved, 1 absent

Motion: Motion was made to approve a 74% Regular pension, effective September 16, 2013, 8:00am, to Fire Lieutenant Gene Chrostowski, as outlined in the pension calculation form. Motion passed: 4 approved, 1 absent

Motion: Motion was made to approve an 82.50% disability pension, effective August 17, 2013, 8:00am, to Fire Chief Antonio Conte, as outlined in the pension calculation form. Motion was dismissed. Discussion took place.

Motion: Motion was made to approve a 75.00% disability pension, effective August 17, 2013, 8:00am, to Fire Chief Antonio Conte, leaving request of an 82.50% pension pending. Upon verification of Chief Conte's vacation time bank by the City of Stamford Human Resources department, whereby 100 vacation shifts shall be added for pension enhancement equating to a 7.5% increase of pension, bringing the total pension percentage to 82.50%. Upon verification of vacation bank a new resolution and calculation sheet shall be presented to the Board for its approval.
