Minutes of the E. Gaynor Brennan Golf Commission; April 21, 2020

Present were: R. Tyska, T. Birkett, M. Briscoe, A. Brantner, R. Judge.

Meeting was held by teleconference due to restrictions set in response to COVID-19. Chairman Tyska called the meeting to order at 6:02 pm.

Adoption of the Agenda

Mr. Briscoe made a motion to approve the agenda as presented, seconded by Mr. Birkett.

Reading of the Minutes

Mr. Birkett made a motion to approve the minutes for the February 18, 2020 meeting, seconded by Mr. Briscoe. **Motion passed unanimous.**

Monthly Report

Mr. Ukperaj gave a fiscal report for the month of March. Rounds were up significantly for the month. Fiscal and Calendar year updates were given on rounds and player revenue. Mr. Ukperaj also reported briefly on impact of golf course being closed due to COVID-19.

Supt. of Greens Report

Mr. Nagashima reported on golf course work. Tree work along golf course fence line is ongoing. Fairways have been re-contoured and areas targeted for seeding. New Green Tee Markers put in place for Forward Tees. Mr. Nagashima gave an update on the re-routing project. Curbing complete, cart path paved and sod installed along 9th tee and 18th green. A leak was found underneath the new cart path that has since been fixed. Upcoming projects are drainage by the 12th tee and completing work on outdoor stairs. Mr. Nagashima stated that while the golf course has been closed projects have been completed such as aeration on greens and tees, along with pre-emergent spraying to be started soon. Mr. Nagashima also noted that seasonal labor has been reduced drastically and no overtime hours are being used in response to the golf course being closed.

Ms. Aulenti expressed that the staff at Brennan did an unbelievable job keeping the course clean, getting golfers out and keeping them safe. Furthermore, the staff did more than any other course to keep everyone safe. This statement was echoed by other members of the Commission. Mr. Tyska clarified to all that the course was not shut down because of anything staff was not doing or was that the driving point behind the Mayor's decision.

Precautions included tee time intervals, advising the arrival of groups for check-in, the closure of the practice green to all except for groups playing who are on deck, carts remaining in staging area, the wearing of masks and gloves, and more.
