Mr. Birkett reported that the main deterrent is cost.

Mr. Sullivan reported that we have moved the tee marker forward approximately 50 yards.

Mr. Jokhakar reported that prior, he was getting approximately 15 balls per week, now he is getting approximately 5 balls per week.

Mr. Sullivan reported that it is approximately 150' to extend the netting to their house and with tree removal, could cost \$100,000

Ms. Albano reported that she would look into his previous claim for damage to his home.
