New Business

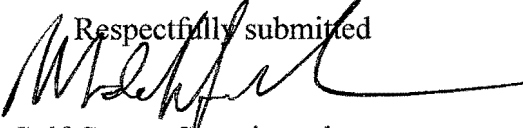
Mr. Sullivan reported that greens are to be aerated October 18th and 19th.
